

ORDINANCE NO. 1-1991
SHENANGO TOWNSHIP, LAWRENCE COUNTY
WEIGHT LIMIT FOR CROWE STREET, WOODROW STREET
MOTOR STREET, ROOSEVELT STREET, GRIGSBY STREET
CARR STREET, BASILONE DRIVE, HIGHVIEW DRIVE
SERVICE STREET AND SAVANNAH GARDNER ROAD

WHEREAS, the Township of Shenango has requested and secured an Engineering and Traffic Study of the following roads: Crowe Street (T-546), Woodrow Street (T-550), Motor Street (T-544), Roosevelt Street (T-542), Grigsby Street (T-568), Carr Street (T-562), Basilone Drive (T-570), Highview Drive (T-569), Service Street (T-564) and Savannah Gardner Road (T-429) within Shenango Township, Lawrence County, Pennsylvania; and

WHEREAS, said Engineering and Traffic Study as performed by the Township Engineer recommends a weight limit and posting of said roadways be as follows:

Speed Limit: 35 MPH
Weight Limit: 15 tons

NOW, THEREFORE, BE IT ORDAINED AND ENACTED, by the Board of Supervisors of Shenango Township, Lawrence County, Pennsylvania, and IT IS HEREBY ENACTED AND ORDAINED by the authority of the same as follows:

That Crowe Street, Woodrow Street, Motor Street, Roosevelt Street, Grigsby Street, Carr Street, Basilone Drive, Highview Drive, Service Street and Savannah Gardner Road shall be posted with a speed limit of 35 MPH and a Weight Limit of 15 tons; and

Further, that said posting shall be in accord with the recommendations and specifications of the State, as well as the Township Engineers; and

Further, that vehicles exceeding the posted weight limit of 15 tons and exceeding the speed limit of 35 MPH shall be subject to penalties as prescribed by the Pennsylvania Vehicle Code and other applicable Pennsylvania Statutes; and

Further, that the Traffic and Engineering Study of said roadway is attached hereto and made a part hereof.

NOW, THEREFORE, be it ordained and enacted into an Ordinance by the Board of Supervisors of Shenango Township, Lawrence County, Pennsylvania, on this _____ day of _____, 1991.
